**Education Property Tax Designation Provisions of *The Education Act, 1995***

Subsection 53(2)

“Where the minority religious faith, whether Protestant or Roman Catholic, has established a separate school division, a property owner is to be assessed with respect to his or her property:

- (a) in the case of a member of the minority religious faith, as a taxpayer of the separate school division
- (b) in any other case, as a taxpayer of the public school division.”

Subsection 296.1(1)

The information that may be required for the purposes of subsection 53(2) must be submitted in the prescribed form.

Subsection 296.1(2)

Notwithstanding section 246 of *The Urban Municipality Act, 1994*, section 288 of *The Rural Municipality Act, 1989* or section 196 of *The Northern Municipalities Act*, any notification dealing with the payment of taxes to a public school division or separate school division must be in the prescribed form.
